Shall Bill 157 be carried? At this moment, I'll ask if there is any debate? None? Are the members ready to vote? Yes? All those in favour, please raise your hand. All those opposed? Seeing none, I declare Bill 157 carried. Congratulations.

At this time, I am going to seek your permission: Shall I report the bill to the House? Any debate? Seeing none—okay.
